[European] Internet

RIPE-001

The objective of RIPE is to ensure the necessary administrative and technical coordination to allow the operation and expansion of a pan-European IP network.

RIPE-001

RIPE acts as a forum for the exchange of technical information and the creation of expertise on IP networking.

RIPE promotes and coordinates interconnection of IP networks within Europe and to other continents.

RIPE establishes agreement on common network management practices and the operational management of the interconnected networks.

RIPE serves as a focal point for other common activities of the participants related to IP networking.

In membership, decision making, discussion

RIPE is pretty good here. Only 40% of North American resources holders are voting members of ARIN (up from 17%), representing 67% of the address space

Until very recently, APNIC was actually owned by one man. yes, of course a man

Transparent

- Finances completely open and published
- All policies, internal and external openly discussed and published
- All decision making (board, exec, committees) open to all and openly published

Civility

- In discourse, treatment of community members, of each other.
- E.g. there should be an enforced code of conduct and other modern guides

Diversity

- The usual gender, race, religion, age, etc.
- But also encourage and seriously consider diversity of goals and opinion
- Disagree and Discuss Constructively

Representative

- Of as wide a range of *Stakeholders* as possible
 - operators
 - education
 - government
 - users
 - civil society
 - geography

Operational Competence

Record keeping, usable APIs/GUIs, ...

Inter-RIR interoperability
